Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust. Do not handle damaged containers or the leaked product before donning appropriate protective gear. 8.2. Exposure controls.

HAND PROTECTION

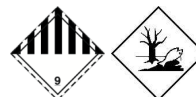
